#### PREAMBLE

Whereas the congregation of Owens Mills United Methodist Church has experienced the loss of its physical facility by fire, and whereas they have subsequently studied the future and then inquired about the possibility of merger with the Chemung United Methodist Church, and whereas preliminary discussions with the Chemung United Methodist Church Administrative Board have resulted in agreement to pursue the details of merger, the following resolution is proposed to be voted on at a Charge or Church Conference held in the Chemung United Methodist Church at 7:00 P.M. on April 16, 1987, said Charge or Church Conference to be held for each congregation, and presided over by the District Superintendent at that time.

#### RESOLUTION FOR MERGER:

Be it resolved that the congregations of Owens Mills United Methodist Church and Chemung United Methodist Church unite in a single, merged congregation effective July 1, 1987. The merged congregation will be located in Chemung, New York, utilizing the United Methodist Church facilities, and will be known as the Chemung United Methodist Church.

Terms and conditions:

- 1. Membership Those members of the Owens Mills United Methodist who desire to unite with another church, different from the merged church would make such transfers and arrangements as necessary by July 1, 1987. On July 1, 1987, the remaining members on the roll of the Owens Mills United Methodist church will be administratively transferred to the Chemung United Methodist Church, and included in the roll of the Chemung United Methodist Church.
- 2. Assets of Owens Mills United Methodist Church Any fiscal assets held by the Owens Mills Church as of July 1, 1987 will be transferred to the Chemung United Methodist Church, and held in trust or endowment funds named the "Owens Mills Endowment or Trust Fund". Only the

- 3. Sale of property of Owens Mills Church The sale of the property of the former location of the Owens Mills church and surrounding land to an agreed upon purchaser of the property will be consumated prior to July 1, 1987.
- 4. Legal fees and court costs Legal fees and court costs for any and all the details of merger and property sale will be paid for from the assets of the Owens Mills United Methodist Church prior to July 1, 1987

3. Appartorments, Panson Fund, and Partoral Support General be paid in full and FOOTNOTES TO MERGER( Not a part of the resolution, but simply for clarification and information)

- Between April 16, 1987 and July 1, 1987, the encumbent pastors of the congregations and their church officers would work at creating and providing "getting acquainted" opportunities for members of the merging congregations, both in worship and fellowship.
- Until July 1,1987, the encumbent pastors will be responsible for pastoral services needed by their respective congregations.
- 3. As of July 1, 1987 the pastor of the Chemung United Methodist Church will be the appointed pastor by the Bishop, and the current pastor of the Owens Mills United Church will be eligible for re-assignment by the Bishop and in conjunction with the Cabinet.
- 4. It is expected that the merged congregation act with

Colleagues,

I simply want to summarize what I believe were the resolves agreed upon in our meeting of yesterday, March 23. It was a good meeting in which I believe we touched some crucial matters. Here is where I perceive we came out:

- 1. We agreed upon a time line which has as its effective date for merger, July 1, 1987.
- 2. Both pastors of Owens Mills and Chemung will post notices of a charge(actually, I believe "church conference" is a bit better for this case...it invites more people to participate) to be held on April 16, 1987 at 7:00 P.M. in the Chemung church building. Each church would need to vote on the following:

Owens Mills - vote on sale of property, and on the merger.

Chemung - vote only on the merger resolution.

My suggestion is that each church create the necessary announcement to convey this action needed in church bulletins on April 5 and 12 which would satisfy the requirements of The Discipline.

- 3. On April 7th, each pastor and two lay persons would meet with me here at the district office at 7:00 P.M. to consider the "terms and conditions" of the merger resolution to be voted on at the April 16th conference.
- 4. After the voting on the resolutions on the evening of

April 16, then we would join together in a service of holy communion and this would commence about 7:30 P.M. and could help celebrate the future. Elaine, Peter and I would share in parts of that service. Elaine and Peter will determine and prepare the details of the communion service, and I will provide a brief meditation.

- 5. After the meeting of April 16, and leading up to the effective date of July 1 for merger, Elaine and Peter will be working on a series of occasions, worship and otherwise, to provide a "getting to know you" atmosphere through which the transition can be made most smoothly.
- 6. The Rev. Fred Turner is our legal counsel in this process and has agreed to prepare legal documents needed to enact the property sale and related matters.

I really appreciate the attitude of both Elaine and Peter as we move toward this significant event in the lives of the congregations. Our continued Christ-like spirit in all this will carry us well into a new era of high purpose for God's Kingdom.

Please let me know if I seem to have misinterpreted our plan of action.

Dear Friends,

My conversations and various communications with your congregations have confirmed your mutual willingness to pursue merger of the congregations due to the Owens Mills building destruction by fire.

Here are the steps necessary to get this in place as I see it:

- The Owens Mills church needs to do the legal transaction necessary to sell or deed the property where the former church was located to the Grace family.
- The old hall across the road from the former church should either be dismantled, torn down, or arrangements for such made.
- 3. Owens Mills members who do not intend to join the merged church with Chemung should transfer their membership to other area churches, or wherever they choose, by let us say, mid-April. All remiaing members after that would then be included in the membership of the merged church.
- 4. When all the legal matters and membership transfers are completed, and Owens Mills is ready for merger, then the fiscal or other assets remaining would be carried into the life of the merged church. The terms and conditions of endowments, trusts, and other details of merger could

be explored by a joint committee of the two churches.

5. A Charge or Church Conference then would be held for each church in accordance with paragraph 2541 of the DISCIPLINE in which the terms and conditions, details of merger cleary set forth in a resolution and voted on affirmatively by each congregation would confirm merger.

I would like to see us move on these details so that perhaps in May we would have the Charge or Church Conferences. If it takes longer, that is alright, but I think the sooner, the better for all concerned.

At this point, Owens Mills needs to get going on the property issues and membership transfers as soon as possible.

I have spoken with the Rev. Fred Turner, (733-9074) retired United Methodist pastor and practicing Attorney-at-law who resides in Pine City. Fred is willing to guide the Owens Mills Church through their legal needs and generally advise us as we proceed. Funds for legal matters and fees may be used from the Owens Mills assets at this time. I am asking Arthur or Madge Grace and Rev. Peter Bean, Pastor to please contact Rev. Turner in order to get going on this, and I am copying this letter to him.

I shall keep you all informed as we move toward a joyous union of your churches, and the on-going spirit of the Owens Mills congregation in the larger Body of Christ in all this.
